Sub : Non-compliance of Real-time Monitoring Provisions by Industries

Ref. : Monthly Report on Status of Compliance by industries.


The Govt has initiated programme for self monitoring of compliance by 17 category of industries, Grossly polluting industries and common treatment facilities. As part of compliance the industries are required to install requisite online realtime monitoring systems and establish connectivity of the same with M.P. Pollution Control Board for live streaming of monitoring data.

It has been noticed that the industries have installed the real-time monitoring systems but there is still shortfall as some of the industries are not complying the protocol fully. They are either monitoring less number of required parameters or not communicating the data. This was discussed during the review meeting also and all the field offices were directed to make use of CSS and keep a constant watch on the industries but the report is not yet received.

In view of above there is strong need to verify that all the target establishments under your region comply the provisions of Real-time monitoring in toto. It is urged to look into the matter and pursue the industries for total compliance. Apprise the compliance status to this office within two weeks time.

N.B. :

- 1) The water polluting industries are required to install CEQMS. In case of ZLD industries they need to install IP-Camera and Flow meter instead of CEQMS.
- 2) Installation of IP-Camera with CEQMS may be encouraged to help us check the W/w discharge remotely and avoid the physical inspection.
- 3) The above status is based on the information available with ESC.
- 4) The RTM parameters for Fertilizer industries are to be decided as per MoEF&CC Notification No. G.S.R. 1607(E) dated 29.12.2017 depending on the plant process.
