Sub: Non-compliance of Remote Calibration System by Industries.

As part of self monitoring of compliance and and keep a constant watch on industrial pollution, the 17 categories of industries and Red category industries have been asked to install real-time monitoring systems and connect the same to the MPPCB for remote surveillance purpose.

In order to ensure the reliability and authenticity of real-time monitoring data, being received at MPPCB, the industries have been asked to provide facility for remote calibration of continuous emission monitoring system (CEMS) and continuous ambient air quality monitoring system (CAAQMS) and provide access of the same to the Environment Surveillance Centre (ESC) for designated purpose.

It has been noticed that most of the industries under your jurisdiction have not provided facility for remote calibration of CEMS and CAAQMS. List of such defaulter units is available on website and the same can be referred at URL <http://www.erc.mp.gov.in/ESC/DefaulterRCSUnits.aspx>. You are requested to take an immediate note of this lapse and pursue the defaulter industries to ensure Remote Calibration facility for the stated purpose and intimate the same to the Environment Surveillance Centre (ESC) in a fortnight's time.
