Sub: Lack of compliance of IP-PTZ-Camera operations under your jurisdiction.

As part of self monitoring of compliance and in order to avoid undue human interference in industries and keep a constant watch on industrial pollution the industries have been asked to install IP-PTZ cameras in their premises at strategic locations for remote surveillance purpose.

All the 17 categories of industries and Red category industries with significant pollution potential are being targeted in the first phase. Some of the industries have complied the installation in line with the requirement but some units under your jurisdiction still needs to be pursued for early compliance.

While examining daily status of cameras under your jurisdiction it is observed that out of 24 IP-Cameras installed only 10 are PTZ type and the rest are static type. It is also evident that cameras in 03 units are not in regular operation since last over three months and in 05 units since last over six months. Apart from this the cameras in 04 units are not in operation since the inception. It is also observed that the location of installed cameras is not appropriate and does not serve our basic purpose.

In view of above it is directed to inspect the industries and direct them to install IP-PTZ-Cameras, instead of static cameras, and also see that the location of cameras serve our basic purpose of remote surveillance. If there is need of installation of more than one camera in any premises, direct the industry accordingly and make sure that all the cameras in all the industries remain operative and connected with ESC, MPPCB round the clock. Your follow up report containing facts and suggestions/recommendations should reach to this office within 15 days time.

List of all the above units is appended herewith for reference and onward necessary action.
