Procedure for Registration of Remote Calibration:

Step 1: Access the Registration Page

• First, go to the registration page by clicking on this link: - <u>https://erc.mp.gov.in/IMS/CRUD/CAL_registration</u>

Step 2: Pick a Date and Time

• Choose a date and time for your remote calibration session. Keep in mind that if someone else has already chosen that date and time you will not able to select that date, you'll need to select another one.
