Sub: Relocation of CAAQMS from Industry premises at suitable City Locations.

As you are aware that the real-time monitoring of air quality has become indispensable for timely intervention to check the pollution level. The air monitoring of a city requires several stations to get a proper representative picture and to address this the MPPCB has already initiated establishing air monitoring network in the State. A total of 10 CAAQMS have been installed at 10 various locations in the State but this number is too small to give a representative picture of the air quality of the State. The process is on to procure more CAAQMS to cover larger area.

The industrial units in the State have also installed CAAQMS in their premises for self monitoring of compliance. Some of the industries, which have 3 to 4 number of CAAQMS in their premises, have shifted one CAAQMS to other location in the city. This shifting has not only helps in optimum utilization of available resources but also helps in avoiding duplicity of air quality data being generated from their nearby or adjoining industries.

As per the attached list there is scope of shifting 28 Nos. of CAAQMS to the city locations from the premises of industries. This was discussed and informed to all the representative of Regional offices by Member Secretary during State level workshop for MPPCB officials on Central Server Application for Real-time Monitoring held at Bhopal on 15.11.2019.

In view of above it is requested to go through the attached list and pursue the target industries, falling under your jurisdiction, to relocate one of the CAAQMS from their premises to the other location in the same city or in the adjoining city. Regional officers are expected to explore further possibility to increase the number of CAAQMS to cover more number of districts of the State. Take up this task on priority and apprise the undersigned with progress in a month's time.
