Sub: Capacity Building Programme on CEMS and RTM Protocols for Coal-based Power Sector at Bhopal from 19-22 July 2022.

The GoI has initiated a self-monitoring of compliance mechanism under which the target industries, including thermal power plants, are required to install real-time monitoring systems (RTMS) and establish connectivity with central server at MPPCB for transmission of data on real-time basis. The quality and reliability of data is a pre-requisite.

As part of compliance the thermal power plants have installed the Real-time Monitoring systems (RTMS) but the selection of instrument and its performance check for the reliability of data is still not satisfactory. A proper architecture of data communication and genuineness of transmitted data are also important areas which need to be addressed to achieve the objectives of self-monitoring mechanism.

In order to further strengthen the environmental governance in the State, and to provide a platform to interact with the experts, a four-day capacity building programme is being organised at Bhopal, particularly targeting the 'coal-based power sector'. The programme is supported by the US Deptt. of State (USDoS) and is being executed by the International Centre for Sustainable Carbon (ICSC), UK in coordination with M.P. Pollution Control Board. This includes one day field visit to thermal power station too. The experts / speakers shall be from EU, ICSC, US and the Indian regulatory agencies.
