With reference to CPCB letter dt. 02.03.2015, you are directed to:

- (ii) If the industry will not install the online monitoring system by June 30, 2015 their consent to operate of the industry shall be withdrawn and bank guarantee shall be forfeited.

You are requested to furnish the information in enclosed format regarding installation of Continuous Stack Emission Monitoring System (CEMS)/ Continuous Ambient Air Quality Monitoring System (CAAQMS)/ Continuous Effluent Water Monitoring System (CEMS) in the industry latest by 08.06.2015.
