This has reference to para 14 of the order dated 08.06.2020 passed by Hon'ble National Green Tribunal in Original Application No. 22/2020 (the matter of Aryavart Foundation through its President Applicant(s) Versus Yashyashvi Rasayan Pvt. Ltd. & Anr.) which is reproduced below:

"Since this tragedy follows so close on the heels of a similar one (in Vizag)., it may be necessary to ensure that risk studies are duly undertaken by all industries in the country dealing with the hazardous chemicals and their on-site and off-site plans are operational and mock drills are carried out for testing the same. The State PCBs, concerned District Magistrates, CIFs of the Industries Departments may ensure the same and the nodal agency for the purpose will be the State PCBs, which may be monitored by the CPCB in an appropriate manner."

Further, Central Pollution Control Board has already issued directions under Section 18 (1) (b) of the Water Act, 1974 and Section 18 (1) (b) of the Air Act, 1981 on 07.11.2017 for effective implementation of The Manufacture, Storage and Import of Hazardous Chemical Rules, 1989 and communication dated 08.05.2020 regarding strict safety precautions to be taken by the industrial unit; before resuming operations.

In view of above, it is requested to ensure the necessary actions are taken in compliance to order passed by Hon'ble NGT.

The action taken report shall be submitted to Central Pollution Control Board at the earliest.
