A Note on the Proceedings of the Workshop

The Emergency Response Centre, Bhopal organized an out-reach program on "Chemical Safety, Preparedness and Emergency Response" at Malanpur industrial area in Madhya Pradesh on 30th June 2011 to create awareness among the industry personnel, the different first responder groups (the officials from Police, Fire brigade, district administration , Department of Industrial Health & Safety) and also the people living in the vicinity of chemical industries.

The program started with the welcome address from Shri R.K. Gupta, Regional Officer, M.P. Pollution Control Board, Gwalior. The program was inaugurated by Dr. N.P. Shukla , the Chairman, M.P. Pollution Control Board and Shri K.K. Tiwari, Managing Director, Audyogik Kendra Vikas Nigam, Malanpur. This was followed by opening Remarks by Dr. Gunwant Joshi, Chief Chemist and Head of Emergency Response Centre explained the need of organizing such programmes and highlighted the importance of preparedness in the chemical emergencies. The chief guest of the program Dr. N.P. shukla, under who's initiative and directions the activity was organized, praised the efforts of the ERC in taking the issues of chemical safety and preparedness to it's member industries and the first responders and said that the ERC should be vigilant and should go to all its members in their settings and have a feel of the area and the problems faced by the industries in maintaining high levels of preparedness to meet chemical emergencies. He also asked the industries to avail full benefits of the ERC and also share all the pertinent information with the Board. He further informed the industries about the concept of transparency and responsibility being the main focus of board's work culture as reflected in

implementation of Narmada XGN an on-line consent management system. Shri K. K. Tiwari who was the special guest of honour praised the initiative taken by the board and stressed the importance of the safety audits in chemical industry. He also stressed the need of Emergency response and Operation Centre at each of the important industrial locations so that all the chemical accidents can be squarely dealt with and the emergency is immediately attended before it turns in to disaster.

Shri Avinash Mishra, Managing Director M/s. Godrej Consumer Care Product Ltd., Malanpur shared with the audience the issues related to the onsite emergency plan and mock drills and thanked ERC for taking-up the out reach program. He further expressed that such programs shall help develop better coordination amongst the industry, the first responders, regulators and the technical support group such as ERC and appealed the fellow industry men to make best use of this opportunity.

The Vote of Thanks was extended by Shri Manoj Jain of ERC, M.P. Pollution Control Board, Bhopal

A total of 72 participants from various industries, District administration, the first responders and regulators (MPPCB and DIHS) attended the programme and were benefited from the workshop. The resource persons as guest speakers were from Central Pollution Control Board, Delhi, National Informatics Centre, New Delhi, Disaster Management Institute, Bhopal and Department of Industrial Health & Safety, Govt. of Madhya Pradesh.

In the 1st technical session, Shri Gurudutt spoke on 'Manufacture, Storage & Import of Hazardous Chemicals Rules 1989 and Chemical Accidents (EPPR) Rules 1996. He informed about status of import of hazardous chemicals in the country and the course that one has to follow, including mandatory provisions like permission from the concerned State Pollution Control Board and Ministry of Environment & Forests, Government of India.
